Mr. Martin Cuellar addressed the Court in reference to line item #21, stating that he is willing to donate \$500.00 to restore the hospital to be used as an emergency disaster location.

26. <u>Discussion of the Brooks County Budget for Fiscal Year 2017-2018</u>, and other related budgetary items.

The court discussed:

- Fund 13-Road and Bridge on increases and decreases to the budget; it was stated to pay two mechanics half from the road and bridge and half from the general fund (On file)
- Landfill Department- discussed that the county take the tires for disposal, instead of paying someone to do it; (On file)
- General Fund- budget includes a tax increase of 4 cents; discussed looking into a ticket writer for law enforcement to make the job easier for the JP's; including a 5% increase to all employees not including elected officials; David T. Garcia discussed in putting monies into a reserve to be used towards a self-funded insurance, maybe even

increasing the taxes and use towards that reserve; discussed grass cutting in county buildings Commissioner Vargas volunteered his time to cut the grass at the Courthouse; it was discussed to add 2 full timers and 1 part timer to the Maintenance Department and to increase Mr. Muniz salary to \$29,705.82 and to increase Mr. Huerta salary to \$24,000.00; it was discussed to increase the salary by 10% across the board;

Mr. Patroelj asked the court to recess for tomorrow to enter the amounts in increasing the taxes to 8 cents.

At 12:38 PM the Court recessed, to reconvene tomorrow Wednesday August 9, 2017 at 1:00 PM.

At 1:09 PM on Wednesday August 9, 2017 Honorable Judge Imelda Barrera reconvened the meeting.

At 1:12 PM the court recessed till the County Auditor was present. The Court continued pursuant to recess at 2:46 PM, present same as before, including August Patroelj, County Auditor, Rodney Belasquez, Internal Auditor and Angie Saenz, 1st Assistant Auditor

The court continued to discuss line item 26.

- A proposal with a 5% increase (\$150,000.00), a 10% increase (\$300,000.00) Raising taxes 5 cents or 7.5 cents in order to do these increases
- County Auditor suggested doing a COLA at \$1,500.00 per employee will be the same as the increase and would only raise the taxes by 5 cents

Commissioner Olivarez suggested the 5%; Commissioner Martinez on comparison on increasing 10 % or 5% recommends the 5% increase to be fair with everyone; it was stated that increasing the taxes to 5 cents or 7.5 cents, it would still be saving the tax payers money; Judge Imelda Barrera stated if you don't give the 10% back why give them a 5%; Commissioner Martinez stated for the record that District Judge Terrell will be coming back to the Court and giving his staff a 5% increase. It was discussed to stick it out another year and wait till next year

- It was discussed by Commissioner Martinez, County Treasurer, Horacio Villarreal III and August Patroelj, County Auditor in passing payroll to the County Auditor's office and will not being needing a part timer in the County Treasurer's office
- It was discussed that 4 cents were already included for the proposed budget, but it was discussed to go with 5% increase across the board
- It was also discussed that Dante Huerta would no longer have a title as the Assistant to Beto Muniz; the Court discussed the mowing of grass for county buildings, and in using the equipment from the road and bridge to do the work needed, new employees for the maintenance department will be making \$19,642.00, Mr. Muniz suggested in starting the new employees at 18,642.00 and giving the rest to Mr. Huerta; Honorable Judge Imelda Barrera suggested in recessing today in order for her proposals to be looked and worked at; Chief Deputy Terri Silvas stated that she needed this to be done today in order for her to meet her deadline;
- Commissioner Olivarez suggested in giving 5% to all who lost their 10%, Commissioner Garza also suggested to give a 5% increase for everyone who lost their 10%,
- Commissioner Martinez stated that if we go out for contract work, that would solve the problem right now for the maintenance department and just give them the 5% and the extra full time and to look at it at the next budget; it was decided to give the maintenance department 2 ½ employees
- County Judge stated to give her 5% to her assistant and Commissioner Martinez stated the he didn't want his 5%
- It was decided to go with a 5% increase for everyone who lost their 10%, which the Court would have to go with a 5% cents increase to the taxes
