1. Public Comments

August Patroelj, County Auditor asked for a moment of silence for Gilbert Vela in his passing and him being a long time County employee. Judge Eric Ramos asked everyone to rise for a moment of silent for Mr. Vela past County Treasurer.

Judge Ramos stated not a member of the County but appropriate as well to mention for good thoughts and for appreciation for Mauricio Lopez a public servant and a member of the school board.

4. <u>Discuss, Consider, and Approve the agreement between Jim Wells County and Brooks County to fund the 79th District Court (including the Judge's and Attorney's Offices) for the 2018-2019 fiscal year. (Submitted by County Judge, Eric Ramos)</u>

Honorable Judge Eric Ramos addressed the Court on the above matter in reference to the audit performed. Judge Ramos stated that in the State of Texas you are not allowed to amend the budget in declaring these an emergency situation, allows the County to amend the budget. Allowing the County to come up with an agreement for both the District Judge and the District Attorney. The District Judge is asking for \$30,000.00 additional to what is already sent to Jim Wells. It was discussed that the County Auditor will be sending a letter to the District Judge's office in reference to the monies asked and having the County take care of the disbursements. District Attorney's office is asking for \$78,000.00 to fund a part-time position, a full time Investigator and 30 % for an Attorney. Carlos Garcia, District Attorney also addressed the Court on the above issue. August Patroelj, County Auditor gave his recommendation on the situation on hand, recommending having the people in house and that the county controls our own finances.

6. <u>Discuss, Consider and Establish Court Findings that the funds approved for the 79th District Court in 2018-2019 and the 2018 Cost of Living Adjustment will not increase the 2018-2019 budget expenses. (Submitted by County Judge, Eric Ramos)</u>

Honorable Judge Eric Ramos addressed the Court on the above matter stating that the district court would come from the fund balance and the cost of living will come from this year's budget. Have come up with a plan Cost of living will cost \$128,000.00 and so are going to establish as a court that will be committing will be staying within this year's but, and come June will sit down and review the budget and review that the expenses stay as should be.
