1. Public Comments

There were no public comments said at this time.

2. Approve of Bills and Claims

3. <u>Discussion of the Brooks County Budget for Fiscal Year 2018-2019</u>, and other related budgetary items.

August Patroelj, County Auditor addressed the Court in reference to medical insurance, ambulance service, retirement numbers, jail salaries, landfill secretary (can't be funding state employees); charging rent to the DPS (MOU); \$100,000 loss of tax valuation

- -Judge Barrera stated she signed a local disaster proclamation signed (letter to the governor for assistance)
- -landfill department-will be short in revenue, how are we going to handle the shortage -Judge Barrera suggested a \$10,000 cut from commissioners court to make up for the shortage-discussed lowering the budget-discussed hiring a collecting agency to do the collecting (lower the projection)
- -health insurance extended the submission for two more weeks; self-funded is a good idea
- -ambulance service; Monday is the last day- if no bids are submitted would stay with the same ambulance service
- -jailers salary; increase the salary to meet GEO Salary (losing employees due to the salary) \$96,000 including fridge and benefits (budgets from DPS and weight scale can be moved to supplement the increase or use sheriff payment for vehicle to pay the increase) \$14.50, 15.50, 16.50 per hour.
- -Retirement-lowered last budget year; increase contribution (employee 5%- employer 2%)
- -Highway department- discussed creating an MOU and charging them \$500.00 a month for rent of the space used
- -Road and Bridge Department- Commissioners' would no longer be paid out of that fund; move their salary and place it in the general fund
- -auditor office looking for a new financial software \$36,000 annual maintenance of 1.5 million, 500,000 526,339.04
- -discussed different budgets
- -county judge \$10,000 from official payroll salary (auditor stated that he will check if that is possibly)

Commissioners court- would be moved to the general fund; move agenda back to the judge; add monies \$1000 to official bonds; \$1500 dues; \$1500 registration; \$2000 out of county travel

County clerk add \$250 for bond

Miscellaneous- property insurance increase \$4000; auto liability damage increase \$8000; technology Ogan contract minus \$10,000.00; technology add \$10,000

County court- reporter -decrease 500.00;

District clerk add \$250.00 bonds

JP's 1-4 add monies for bonds \$250; add office supplies to JP2 \$500

Treasurer's- add Office supplies \$500; add \$250 for bonds

Voter registration- discussed voting machines; decrease \$13,000 from election expense Courthouse and building- add a part-timer as needed \$10,000 (\$8.50 an hour);

Jail; increase the salaries; discussed hiring a full time maintenance person just for the jail; increase prisoner's board \$15,000; overtime add \$5000;

County extension service- increase out of county travel \$4000; increase \$500 for registration;

At 12:07 PM the Court recessed for lunch and to be back at 1:30PM. The Court came back into session at 1:35 PM. Present same as before.

The continued to discuss increases and decreases of the budget: they discussed the following departments:

Constable 1- \$50.00 for Repairs and Maintenance

Constable 2-\$50.00 for Repairs and Maintenance

Constable 3-\$1000 for Gas & Oil; \$50.00 for Repairs and Maintenance

Constable 4- \$50.00 for Repairs and Maintenance

Sheriff's Budget- asked for a full time officer-discussed giving one officer; increase \$2000 to Other Supplies; decrease interest for dept to zero

Sheriff's Traffic Division- increase gas \$3000; add \$500 to Maintenance and Operations

Dispatchers- increase \$2500 to Overtime;

Adult Probation-leave as is

Texas Department of Public Safety- to be all zeros

DPS License and Weights-to be all zeros

Discussed going out for bids for fixing the north bond weight scale

LEPC Coordinator- increase Fire Department Assistance \$14,000; Southern Brooks increase \$6,500; Miscellaneous increase \$3,000

Health and Welfare-leave as is

State Indigent Hlth/Care Program-leave as is

OPC/911/EMS-leave as is
Library- leave as is
Road and Bridge Fund:
Removing the commissioner's salary; out of county travel; increase water (since the commissioners budget will be separated from the road and bridge)
