Judge Ramos stated that since the Governor is reopening the state in phases, the county will also be opening with precautionary measures; cut non-essential travel; cutting part time positions out of the general and landfill budgets; furlough program (one day a month or one day a week); or to look at full time position to cut; or to cut percentages for this year; Judge Ramos stated that we know we are going to be short but would have to look at the numbers; the cuts suggested would be for the months of June-September, but it was suggested that didn't know if that could be possible, County Auditor August Patroelj stated that he didn't think the cuts could be taken and then given back the next budget year.
