5. Budget Workshop

The Court discussed increases and decreases on the following:

- Discussed the 2020-2021 expected revenues for the upcoming budget year
 - o Discussed budget line item #4005
 - o Discussed the tax rate currently being .626000 for the General Fund and that would be possibly going up 7 cents to reach the same as last year
 - o Discussed the delinquent taxes
- That there was a decrease in the collection of JP Fines
 - Decrease in Code Enforcement tickets (there was a period where they were shorthand,
 COVID related, and less traffic)
 - o Projected Weight Station pit being fixed and should be fixed next year; just not as active, but are still collecting some revenue
- Short fall in revenue \$281,297.61 using the formula the County Auditor has used in the past; and will be using this numbers going forward to estimate the tax rate
- Reviewed the increases and decreases to each department
 - o with a 10% cut across the board or a 15% (cuts not including personnel)
 - o removing the COLA would save us \$142,000.00 (the 10% and the complete cut of the COLA would be \$270,356.00 short about \$11,0000.00)
 - o possibility of removing part-timers; discussed going with the 15% saving us \$334,238.00
- Judge Ramos expressed his concern about adopting the tax rate giving us \$337,000.00(69 cents) maybe going down to 67 or 66
- August Patroelj, County Auditor stated that a penny generates \$50 or 60,000; discussed the Road and Bridge being healthy maybe in taking some pennies from them and putting them in the General Fund
