3. Presentation by representatives and agents of Bullhead Wind II, LLC regarding proposed construction of renewable energy project in Brooks County.

Ali James, Bullhead Wind II, LLC (Vestas/Steelhead) addressed the Court on the above matter, in reference to the possibility with working with the County on the Northwest side of the County; in installing 70 wind terminal generators, project beginning as soon as 2022 and construction to begin in 2024 and looking for 30,000 acres. The Commissioners expressed their concerns on this project; it was discussed that it is expected to create 250 jobs with 3 long term positions within the 30-year lifespan period of the windmills. Also discussed was the 30-year lifespan and the disposing of the turbines (disposing plan will be created as well as a fire plan). Discussed installing MET towers to generate information from certain sites, so that they could determine where to place these wind terminals. It was discussed on how to recover loss on a 10 year tax abatement; it was stated that instead of doing a 30 % to do a 100% tax abatement( to enter into a pilot agreement with the company; payment in lieu of tax, project will pay an annual payment over a 10 year period and could be spent how the County chooses).
