PUBLIC HEARING

The Public Hearing was opened with a discussion of the Proposed Tax rate of 0.900847, the No-New Revenue Tax rate 0.888281 and the Voter-Approval Tax rate of 0.963909. Honorable Judge Eric Ramos read Notice in Open Court. Honorable Judge Eric Ramos asked for any questions or comments. Terri A. Silvas stated that nothing has changed from the last meeting. Higinio Garcia Jr, County Auditor addressed the Court in reference to the Road and Bridge Budget and having a difference of \$98,000 due to some miscalculations that he had entered and has been corrected. Irma Menchaca addressed the Court on the increasing of taxes and that decisions are already made; instead of raising taxes need to look into bringing in more businesses. The Court expressed their comments and concerns on the tax rate.


